Key Highlights:

- Emily Pond, Dept of Municipal Affairs
 - Municipal Modernization: increasing collaboration, decreasing competition
 - Discussed experience dealing with the Pictou County amalgamation and how in dealing with that event it led her to issues and need for structural changes.
 - There are dozens of reports showing how our current structure is set out to encourage competition between Municipal bodies rather then cooperation.
 - While there is no formal to show how to modernize Municipalities there are a few key areas where Municipalities can work together: infrastructure, land-use planning, economic development, revenue sharing

 - Using a Regional approach to future-proof our infrastructure
 - NS water frontage is one of our major advantages that we need to utilize.
 - 25000 young people ages 25 to 35 were surveyed, 2/3 of that group said they would pick the place they want to live and then look for a job.

Gathering Talent

CAO Report – September 10, 2018

Economic Development:

- Kelly Greenland started on September 10, 2018 as Economic Development and Planning Officer. Kelly will be focusing on planning document updates over the first several months, with progressive involvement in economic development activities phased in over time.
- Engage St. Mary's event planned for September 22, 2018 9:00 to 12:30 noon at the SHOPS room. Lunch to be provided by Sherbrooke Village
- Working with ESREN to explore potential business attraction opportunities to the area

Finance:

- On August 17th, 2018, over 900 tax arrears notices were mailed out, including 100 tax sale notices advising residents that their account has been deemed subject to Tax Sale proceedings.
- If payment(s) or payment arrangements are not received on potential tax sale accounts by September 24th, then those accounts will proceed through the tax sale process.
- Since August 17th, over \$105,000 has been collected on outstanding taxes. To date the 2018/19 taxes are 88.4% collected and the 2017/18 taxes are 95.4% collected.
- The 2018/19 tax sale is scheduled for mid-December 2018.
- Audited financial statements are ready for Council's review / approval.

Contracts

 CBCL completed the System Assessment Report on the Wastewater Treatment Plant which is a requirement of the Approval to Operate issued by Nova Scotia Environment

Asset Management Project:

• CAO completed the NAMS Canada eight week course which was subsidized by the Federation of Canadian Municipalities. The course involved completing an asset management plan. The Wastewater System was selected as our case study/ plan.

Recreation:

- Summer programs were successful again this year. Eight weeks of day camps
 were offered and participation ran between 15 to 30 each day. Two two week
 sessions of swimming lessons were held in July and August (32 registered in July
 and 38 in August).
- Canada Day events were well received.
- Seniors games were held over two days in August. We had 115 participants from all of Guysborough County.
- Staff are preparing for the Fall and Winter programs. Fall Programs will include Trail Blazers, Happy Feet, and Yoga.
- Active Start Movement Skills program will be introduced at the beginning of October – Beginners to sports
- Way-finding signs were erected in Stonewall Part.
- RecPlex improvements were completed over the summer, including painting boards and the interior of the building, placed new rubber mats for walking track, kitchen cupboards, sprinkler tanks cleaned and painted inside, replaced broken glass sections around boards, and exterior painting is on-going.
